City Council takes a look at e-cigs

CITY HALL Concerned that kids will pick up the unhealthy habit of smoking cigarettes, Councilman Bob Holbrook wants to restrict the use of the electronic version.

Holbrook will ask his colleagues on the dais Tuesday to take a closer look at bans on "vaping" in cities like Los Angeles and New York to see if there is enough research on the health impacts of electronic cigarettes to add them to Santa Monica's comprehensive smoking restrictions, which prohibit smoking tobacco at local beaches, parks, the Third Street Promenade, restaurant patios and even inside apartments.

Holbrook's main concern is that decades of anti-smoking efforts will go up in smoke (or vapor) if teens continue to see "vaping" in public places like restaurants or sporting events. He believes teens will be enticed to use e-cigs because they can be loaded with liquid cartridges that contain nicotine as well as flavoring like cotton candy and bubble gum. Since there's no smoke released,

Good results from Olympic schedule alteration

OLYMPIC HIGH A schedule change that allows students to come in later has been a success at Santa Monica's continuation high school, said Olympic High School Principal Janie Gates.

Gates has decided to stick to the schedule, at least for the rest of the year, thanks to vast attendance improvements in 25 of the school's classes. None of the classes showed a decline in attendance and more than half of the students preferred the

The idea to start classes almost an hour later was the brainchild of classroom teacher, Anthony Fuller, who is researching the biological clocks of adolescents at UCLA's Principal Leadership Institute.

"We had been discussing for years the best ways to improve attendance because we have some of the best truants in the district here," Fuller said.

Olympic High School is designed to help kids who are struggling to graduate within the mainstream school system.

Fuller read studies from research teams all across the world, including Taiwan, India, Europe, and the United States, and found that all teens have at least one thing

Some state cities are seeking water independence

SANTA MONICA, Calif. Drops of rain fell on Josephine Miller's 1920s bungalow — a watery relief in the midst of a punishing drought. Instead of flowing into storm drains and washing out to sea, an oversized tank harvested the precious resource to keep her thirsty citrus trees and vegetables from shriveling up on dry days.

Across Santa Monica, backyard rain barrels and cisterns are becoming fashionable. Since 2010, the beach city has doled out 385 rebates to homeowners who direct rainwater back into their gardens as part of a broader effort to become water independent that also includes cleaning up contaminated groundwater and recycling water.

"This is kind of a no-brainer, low-hanging fruit solution for anyone," said Miller, who three years ago installed a 205-gallon water storage container, which resembles an upright accordion.

California is gripped by historic parched conditions that have desiccated farmland, dried up reservoirs and forced rural communities to ration water. A welcome dousing late last month did little to break the arid



Los Angeles subway dig finds trove of fossils

LOS ANGELES Scientists have long known that long before hipsters and tourists were crowding Los Angeles' trendy Miracle Mile district, prehistoric animals were doing the same.

Now, thanks to a subway dig, they're discovering that sea lions may have been swimming nearby as well.

An exploratory subway shaft dug just down the street from the Los Angeles County Museum of Art has uncovered a treasure trove of fossils in the land where saber-tooth cats and other prehistoric animals once roamed, the Los Angeles Times reported Saturday.

They include mollusks, asphalt-saturated sand dollars and possibly the mouth of a sea lion dating to 2 million years ago, a time when the Pacific Ocean extended several miles farther inland than it does today.

"Here on the Miracle Mile is where the best record of life from the last great ice age in the world is found," paleontologist Kim Scott said.

The area, dotted today with museums, restaurants, boutiques and apartment buildings, also includes the world-famous La Brea Tar Pits. It was there that mammoths and saber-toothed cats got stuck in the pits' oozing muck, which preserved their skeletons for millennia.

The shaft, dug ahead of work scheduled next year to extend a subway line across LA's west side, is now revealing far more material, including geoducks, clams, snails, mussels and even a 10-foot limb from a pine tree of the type normally now found in central California's woodlands.

The Los Angeles County Metropolitan Transportation Authority is working with Cogstone Resource Management and the nearby George C. Page Museum to identify and preserve the prehistoric cache.

More such discoveries are expected when excavation work begins on a nearby subway

"LA's prehistoric past is meeting its subway future," noted transit authority spokesman Dave Sotero.

'Peabody & Sherman' tops box office receipts

LOS ANGELES Street racers couldn't catch a time-traveling dog and his son at the multiplex this weekend.

Though Disney's "Need for Speed" was expected to take the No. 1 position at the box office, DreamWorks' "Mr. Peabody & Sherman" took the lead, with the action film in third place.

The animated movie, about the adventures of a genius dog and the human son he adopted, earned \$21.2 million, according to studio estimates released Sunday. Debuting last weekend at No. 2, the 3-D kiddie-jaunt features voices from "Modern Family" stars Ty Burrell and Ariel Winter.

"Our midweek numbers were very strong, indicating good and positive word of mouth," said Chris Aronson, president of domestic distribution at Twentieth Century Fox. "If anything, this is exceeding (expectations). It's a combination of likable characters and it's a nostalgia play for those who are familiar with the show."

Mr. Peabody and Sherman first appeared in the 1950s and early 1960s on "Peabody's Improbable History," a segment within the animated television series "Rocky and His Friends" and later "The Bullwinkle Show."

"The family marketplace is giving every other genre a run for its money," said Paul Dergarabedian, senior media analyst for box-office tracker Rentrak. "But the St. Patrick's Day effect could be at play here, where families had to exercise their options at the theater rather than the pub. That may have paid off for 'Mr. Peabody.'

Meanwhile, analysts predicted that "Need for Speed," based on the popular EA Entertainment video game and starring "Breaking Bad" alum Aaron Paul, would come in at No. 1 this weekend. But with \$17.8 million, it arrived at No. 3 in the U.S. But the movie raced to the top of the international box office, bringing in \$45.6 mil-

Warner Bros.' warrior drama "300: Rise of an Empire," the 3-D sequel to 2007's "300," dropped to second place, with \$19.1

million, after debuting at No. 1 last weekend. Though its opening haul of \$45.1 million pales in comparison to the original, which debuted with \$70.9 million, "Rise of an Empire" has earned more than \$78 million since its debut.

Tyler Perry's "The Single Moms Club," starring Nia Long and Amy Smart, opened with \$8.3 million at No. 5.

"This is one of Tyler Perry's lowest debuts ever, but he cranks out hits every year for almost decade," Dergarabedian said. "He's allowed a couple of missteps every once in a while."

Leading the year's early trend of films about religion, Fox's "Son of God" grossed \$5.4 million in its third weekend. After opening at No. 2 with \$26.5 million, it dropped to No. 5 in its second week, earning \$10 million. Its performance may indicate that religious stories aren't holding up at box office. Plus "Son of God," starring Diogo Morgado, lacks star power.

However, other upcoming films with a

Who benefits?

The law suit and referendum against the Hines project is a big step in the right direction, but the issue at hand is far more than just the Hines project in particular and over development in general.

Residents need to be aware of just who benefits from development revenues. Developers are not the only special interest that determines who gets elected to the Santa Monica City Council.

I'm talking about the elephant in the room feeding at the public trough; the powerful city employee associations and Santa Monicans for Renters' Rights. The 200member SMRR is running scared and even the 13 member steering committee is changing sides, trying to point the finger solely at developer interests, even though every one on the council has received their endorsements as well. In fact, four current members of the council have received support from SMRR, city employees and developers!

Palihouse: Wrong place, wrong time for this hotel

contentious developments is before the Planning Commission this Wednesday evening. It's the granting of a conditional use permit (CUP) for alcohol service at the Palihouse Hotel (formerly Embassy Hotel and Apartments) at 1001

Palihouse is in the middle of an R3 residential neighborhood at the intersection of Washington Avenue — surrounded by apartment buildings. There's a senior living center across the street. The 38 guest room hotel has only one on-site parking space.

The owners of this boutique hotel (where rooms cost \$300 per night and up) also own another hipster hotel in West Hollywood known for its "cool vibe."

Santa Monica Palihouse owners (1001 Third Street, LLC) are requesting a CUP to allow "on-site sales, dispensing, and consumption of a full line of alcoholic beverages to hotel patrons and their guests in hotel common areas" which are described as a lobby/lounge area, a 6,500-square-foot front outdoor garden area, a rear outdoor patio and including room-service daily, between 6 a.m. to 2 a.m.

A local CUP is necessary for a type 70 California Alcoholic Beverage Control license for general on sale alcohol services as well as a Type 66 license that allows in-room access (mini-bar) to alcoholic beverages for consumption within guest rooms.

Palihouse's neighbors have complained that the recent conversion of a quiet apartment building into full-fledged hotel with virtually no on-site parking but with food services, valet and other hotel amenities has negatively impacted their quality of life.

Now, Palihouse's owners want to add alcohol 20 hours a day. The nuisance situation will not improve when (or if) the booze starts flowing and will make things much worse for already impacted neighbors.

The site has a controversial history. The Embassy was built in 1927 as an apartment building. In 1979, its former owners registered all 38 units as apartments. Rent control fees were paid on them for 20 years.

In 1980, a request for a hotel exemption was denied by the Rent Control Board. The owners failed to provide any evidence units qualified as hotel rooms.

In 1995, an overlay was created that grandfathered "legally existing hotels" in the R3 zone. The Embassy was an apartment building at the time, however six rooms were illegally being used as short stay hotel rooms.

A dispute between City Hall and the then Embassy owners arose over the property's status as a hotel in 1998. Both parties entered into settlement agreements in 2000 and again in 2011 which resulted in City Hall selling out residential neighborhoods for commercial activity by agreeing that the Embassy Apartments had a right to operate

The city attorney should have instead told Embassy owners to "fly a kite" because they were illegally renting out apartments as hotel rooms without a hotel permit or business license. The settlement included a provision to allow the illegal conversion of 19 rent-controlled apartments into hotel guest

Even though the Embassy had no legal standing as a hotel, that didn't stop City Hall from negotiating away the peace and quiet of a residential neighborhood without any public notice, process or review. Absolutely disgusting, but par for the course.

Another closed door "secret" settlement agreement was entered into in 2011. It totally ignored City Hall zoning codes which state that neighborhoods must be protected from commercial hotel businesses expanding into residential zones.

The present owners purchased the Embassy in 2012, and renamed it Palihouse, They renovated the property and added guest perks including a lounge, indoor and outdoor dining and other amenities. Three actual rent controlled apartments remain. And, because City Hall claims hotel activity is a "permitted use," neighbors and residents were screwed, again.

As usual, anything hated by residents is supported by staff. This alcohol CUP is no exception although staff recommends conditions for CUP approval such as limited hours of alcohol service — 11 a.m. to 2 p.m. and 4 p.m. to 7 p.m. outside, extending to 9 p.m. inside.

These conditions and regulating the number of patrons/guests will never work. Hotel guests could host a reception in the front patio with 70 to 100 invitees in attendance. Most of the conditions staff recommends will never be enforced because everyone is a "guest of a hotel guest."

Who's going to monitor the hours when alcohol is permitted? Surely not city staff. And, City Hall has a miserable record of enforcing conditions such as these. Complaints will go un-penalized — and neighbors will suffer.

Bottom line: an alcohol CUP/license will exacerbate a non-conforming use, is inconsistent with the Land Use and Circulation Element (LUCE) of the General Plan that protects residential neighborhoods from commercial intrusion and sets a bad precedent for additional hotel conversions which is why it must be flat-out denied.

Residents are now acutely sensitive to threats to our unique quality of life as evidenced by the recent petition drive to overturn the massive Bergamot Transit Village (BTV) development. Because of rumors that three planning commissioners may run for City Council this fall, we'll all be watching this closely.

A big shout out to neighborhood leaders Armen Melkonians, Kate Bransfield and all of you who circulated — and signed — Residocracy.org petitions to overturn the council's approval of the massive project.

A total of 13,440 signatures were collected. It's an embarrassing repudiation of city management, Planning Director David Martin, planning staff and the four city councilpersons (out of seven) who support hideous, traffic generating, overly large or inappropriate developments like Palihouse.

Fight to save Southeast hemlocks takes new tack

RICHMOND, Va. A beetle the size of a single grain of rice is the latest best hope for hemlocks in the Southeast that have been felled by the millions by an invasive bug.

The beetle eats only one thing: the hemlock woolly adelgid (uh-DEL-jid), and it does so voraciously.

Researchers are hopeful this new beetle will be a worthy adversary, based on releases of the beetles at sites in Virginia and West Virginia. Like the adelgid, the beetle is native to Japan, and they're adapting to their new surroundings.

The introduction of the beetle is the latest tack to save the hemlock, a daunting task amid fears the evergreen could be facing the same fate as the American chestnut, which was virtually wiped out by a blight.

"We're heading down a path that doesn't look promising for the tree," said James "Rusty" Rhea, an entomologist with the U.S. Forest Service in Asheville, N.C. "If it goes unchecked, we're going to see some catastrophic mortality similar to what we had with the chestnut in the 20s and the 30s and the 40s."

The adelgid has left a terrible path of destruction in forests along the Eastern Seaboard since it was first identified in Virginia in 1951. Its impact has been less severe among interior sections of the Northeast, where long, cold winters keep the pest in check, but it has devastated hemlock stands in Virginia, the Carolinas, Georgia and Tennessee.

The bug has wiped out 90 percent of the hemlocks in Virginia's Shenandoah National Park and has taken a big bite out of stands in the Great Smoky Mountains. Approximately three-quarters of the hemlocks are infested on the East Coast, while the Southeast has seen nearly half of its hemlocks wiped out.

For the woolly adelgid, it's been an allyou-can-eat buffet. The bug eats only hemlocks and it has no native predators.

To combat them, researchers first brought in a beetle from the Pacific Northwest, known by the scientific name of Laricobius nigrinus.

"From an anecdotal standpoint, it's been very encouraging," Scott Salom, an entomologist in the College of Agriculture and Life Sciences at Virginia Tech, said of the beetle. "All the managers out there are excited about

While effective, the latest anti-adelgid beetle has been more aggressive, with an appetite to match. Its scientific name is Laricobius osakensis.

The adelgid literally sucks the life out of hemlocks. Once hatched, they attack the tender shoot of a hemlock's new growth, inserting a filament-like appendage into the base of the needle to feed on cells and wood tissue.

The infestation eventually turns a robust evergreen into what Rhea described as a gray ghost. The ravages of can be seen in the dull, shadowy profiles of hemlocks forests in the Southeast.

While the adelgid was discovered a little more than 60 years ago on the East Coast, it probably had taken up residence in hemlocks decades earlier. They likely hitched a ride on ornamental hemlocks shipped from Japan.

The introduction of this new, improved beetle to combat the bug illustrates the challenge of combatting an invasive species.

While chemical treatments can be used against the infestation, it is considered too labor intensive and expensive. It also raises environmental concerns.

So-called biological controls — using a nonnative predator to kill the invasive pest also are a time-consuming endeavor.

The perfect match must be made, federal permission is required to bring in a nonnative bug, then it must be quarantined before it can be released to ensure it doesn't introduce a new set of problems. They also must be bred to effective numbers to fight the pest, and introduced to infested hemlock

Reproduction was the problem with the first beetle, the Laricobius nigrinus.

"It's a numbers game," Salom said. "We can't produce the numbers we like because they're very hard insect to rear."

While excited by the new beetle, scientists say managing the hemlock-eating pest will likely take a multipronged approach, including chemicals.

Scientists are intent on combatting the adelgids because hemlocks are important ecologically. While hemlocks are cut and milled in New England for siding, in the South they are primarily valued for their ecological role.

Their shade cools streams to a temperature that sustains native trout and they provide shelter for birds that migrate north to nest, such as warblers.

The adelgid has also taken its toll on his-

Cutting down greenhouse gases

If "cap and trade" has worked so well in Europe for reducing greenhouse gas emissions there, why haven't we tried something similar here in the U.S.?

luters must pay to emit greenhouse gases against a capped total amount that is reduced over time has been in effect across the European Union (EU) since 2005. This so-called Emissions Trading System (ETS) requires 11,000 of the largest electric and industrial facilities in 28 European countries to participate. Some 45 percent of Europe's total greenhouse gas emissions are regulated under the system. Proponents say the ETS has succeeded in keeping greenhouse gas emissions in check and making Europe a global leader on climate. The EU reports that, by 2020, emissions from sectors covered by ETS will be 21 percent lower than they were in 2005 and 43 percent lower by

But critics argue that Europe's reduced emissions may be more due to the global recession than the ETS, and that the cheap availability of allowances has made it easier for companies to pay to burn coal than to switch to cleaner natural gas or invest more in carbon mitigation technologies. Early in 2014 the EU tightened up its system by cutting the number of new allowances it plans to issue over the next three years by a third while simultaneously creating a "market reserve" to absorb extra allowances as need-

Meanwhile, Switzerland, New Zealand, Australia, Kazakhstan and South Korea have each set up their own national cap-andtrade programs to varying degrees of success, while regional versions have popped up within Japan, Canada and the U.S.

As to the U.S., whether or not to establish a nationwide cap-and-trade system here has been a hot topic of discussion in Congress. It last came up for a vote in 2010, but never

found enough bi-partisan support to become the law of the land. But in lieu of any federal system, two U.S. regions have undertaken their own attempts at ratcheting down greenhouse gas emissions through market mechanisms:

In 2009, 10 Northeastern states came together to create the Regional Greenhouse Gas Initiative (RGGI), a cap-and-trade system with the goal of reducing regional carbon emissions from the power sector 10 percent from 2009 levels by 2018. Lower emissions than expected over the first five years of the program-thanks to many utilities switching over to cleaner burning and increasingly cheaper natural gas as well as less overall economic output due to the recession-led RGGI to lower its overall annual cap from 165 million to 91 million tons in 2014, with a 2.5 percent reduction every year thereafter until 2020. Analysts expect this rejiggering will drive the price of polluting five times higher than it has been and thus force utilities across the region to seek cleaner, greener alternatives to coal as an electricity feedstock.

The other major U.S. cap-and-trade player is California, which launched its own ETS in 2013 with a cap set initially at two percent below 2012 emission levels. The cap will then be reduced three percent a year from 2015-2020. Some 600 facilities are big enough polluters to qualify for participation in the system, which will cover around 85 percent of the state's total greenhouse gas emissions. Given that California in and of itself is the 12th largest economy in the world, its forward-thinking commitment to cap-and-trade gives hope everywhere to fans of marshalling market forces to bring about environmental change.

Jersey shore rentals slow in second post-Sandy season

TOMS RIVER, N.J. In a normal year, many of the prime summer beach house rentals at the Jersey shore would be gone already, snapped up by vacationers months in advance.

This is not a normal year, again.

As the second summer season following Superstorm Sandy approaches, shore rentals are still available because of a combination of factors keeping many renters from making up their minds as quickly as they had in years past. That's good news for vacationers, who could have more options than usual, but not-so-great news for shore towns counting on this summer to be noticeably better than last year's.

Cyndy Yates, of Valley Forge, Pa., is one of the late bookers. She decided last week on a place in Avalon because her usual rental is being renovated.

"We would make our decisions definitely by January at the very latest," she said. "A lot of times, between November and the end of the year, we would know where we were going to rent."

A big factor in the late-developing market, particularly in Ocean County, is the ongoing project to rebuild Route 35. That is the second-busiest highway at the shore, a crucial north-south route winding through beach towns that were among the hardest hit by the Oct. 29, 2012, storm. Lane closures, stop-and-go traffic and heavy equipment tearing up pavement have led to massive backups during the winter.

Another factor is uncertainty over which beaches will be open for the 2014 season as repairs continue in the worst-hit shore towns.

And a seemingly never-ending series of winter storms and frigid temperatures has kept people huddled inside instead of driving to the shore to check out potential vaca-

"Right now, traditionally, people from up north drive down and look at rentals," said Lee Childers, a real estate agent who handles properties in some of the hardest-hit areas of Ocean County, between Point Pleasant Beach and Seaside Heights. "To tell it like it is, our challenges are still daunting. A prudent renter may be saying, 'I'm going to go there in June and see what the beach and Route 35 look like."

Childers said the pace of rental activity in his region so far is about the same as it was a year ago, when parts of the shore still sat in ruins, but he expects it to pick up soon.

That's good news for New Jersey tourism officials, who are still working on the successor to last year's "Stronger Than The Storm" campaign to entice vacationers back to the shore. Business and local tourism leaders had complained that last year's ads, which didn't start until Memorial Day weekend, came much too late to salvage the season, and called for the 2014 campaign to begin in

woman for the state Economic Development Authority, said no launch date has yet been set for this year's ads.

Some parts of the shore are recovering quicker than others. Lavallette, for instance, has rebounded so well that many property owners have stopped offering the price breaks they had to give last year to attract renters.

Steve Krug, the rentals manager for an agency that rents 300 properties in Lavallette and the Ortley Beach section of Toms River, said the two neighboring towns suffered vastly different levels of damage. Ortley Beach was so devastated by the storm that his agency only managed two rentals there all summer — for a bayside house with a pool.

This year, rental activity is starting to pick up in Ortley Beach, with bargain hunters realizing they can get a house across from the ocean at a 20 percent discount — if they're willing to risk having to listen to hammers and saws during their summer vacation as the neighborhood rebuilds.

Krug said an announcement this month that Toms River plans to have all its beaches open this summer will go a long way toward helping rentals. He said many potential renters were holding off making a commitment until they knew which beaches they could use.

"When I started here in 2001, there was a trend of people booking earlier and earlier," Krug said. "They would say Presidents Day was the signal for people to come down and start making plans. Then it got to be New Year's Day, and finally, it moved to November and even October. It had been falling backward, but it sprang forward last year. This year you're going to see the same thing. All these things are pointing toward a late rush."

An unusually harsh winter has also hurt the rental market so far.

"We see an actual spike in bookings when the snow is gone and the temperature moderates," said Michael Loundy, a Seaside Heights real estate agent who rents properties including the beachfront house that served as home base for MTV's "Jersey Shore" reality series. "We have seen that in the past week with people getting spring

He said the pace of rentals has been about the same as last year's.

"But this is a completely different story in two weeks, as long as we don't have another blizzard," he said. "I think you'll see things

Ann Delaney, a real estate agent in Avalon, says bookings in her area are up about 10 percent over this point last year. She has noticed a trend over the last six years, since the Great Recession hit, of people being less willing to commit to rentals far in advance.

'People aren't as willing to put down \$4,000 in October for a rental they're not using till the following July," she said. "But now when it gets to be April and May, we don't

their water from the overtapped Colorado River and Sacramento-San Joaquin River Delta have taken steps to slash their dependence on water from outside sources and boost their own supplies. Past drought woes, particularly in the late 1980s and early 1990s, have forced some communities to rethink where their water comes from, and they're increasingly realizing local sources are insurance against future dry weather.

Santa Monica, population 92,000, has perhaps the loftiest goal: to completely wean itself off outside water by 2020. The city long depended on its groundwater wells, but supplies became polluted in the mid-1990s from underground gasoline storage tank leaks and the addition of a fuel additive.

The contamination forced Santa Monica to buy most of its water from the Metropolitan Water District of Southern California, a giant wholesaler that provides drinking water to nearly 19 million people in six counties. Meanwhile, the city used proceeds from settlements with oil companies responsible for the pollution to purge the wells. The cleanup, completed three years ago, allows the city to tap groundwater for up to 70 percent of its water needs.

About 50 miles to the northwest, the semi-agricultural community of Camarillo receives about 60 percent of its water from the State Water Project — a maze of dams, pipes and canals that carries snowmelt from the Sierra Nevada and transports it to points south — that it blends with salty groundwater sources.

The city wants to cut down its imported supplies to 25 percent before 2020 and has invested in a \$50 million regional treatment plant that would pump and treat brackish groundwater into drinking water.

"We want local reliability and the ability to control our own destiny," said Lucia McGovern, deputy director of the city's Public Works Department.

The Southern California port city of Long Beach, which relies on outside water for 40 percent of its drinking water, studied the possibility of building a desalination plant, which separates salt from ocean water. But it was too expensive, and the city is now focused on increasing groundwater supplies.

A recent amendment to a court order deciding groundwater rights would allow Long Beach to pump more water. It's in the very early stages of drawing up a multimillion-dollar plan to build miles of pipelines to move the water.

While maximizing groundwater is key to cutting down on distant imports, which can be fickle depending on the weather, it's not an option for every community.

Groundwater is "not available everywhere and it also depends on the quality," said Jennifer Persike, a spokeswoman for the Association of California Water Agencies. "You have to be careful not to overpump it."

While Santa Monica bets on groundwater, it's also investing in other water conservation tactics, including recycling and rain harvesting. Near the touristy Santa Monica Pier, a water recycling plant treats excess irrigation and other urban runoff that is then used to water parks, school grounds and a cemetery.

The city also collects rain. The main library has a 200,000-gallon underground cistern that captures raindrops to water the gardens. Last year, officials installed a smaller cistern that will fill toilets at a newly built library scheduled to open next month.

Since 1997, the city code requires that new construction and remodeled homes must catch the first quarter inch of rain.

During a recent downpour in late February, Miller checked on her cistern, which she bought from a hardware store and installed by rerouting the downspout. She paid \$571 for the tank, which is bolted to the side of her house for earthquake safety, and the city reimbursed her \$250. As rain funneled from the roof into the beige cistern, water from neighboring houses coursed down the street like a river.

Though Miller's yard consists mostly of cactus and succulents — she's in the process of ripping up the last patch of grass — there are orange, lemon and kumquat trees, and a small vegetable bed of green beans, sweet peas and snap peas that need water. A full tank typically can last for months, allowing Miller to tend to her water-needy trees and vegetables on rainless days.

While rainwater capture does little to affect the water table, it does reduce potable water demand.

"I don't think it's as dramatic as buying an electric car, but if everyone in LA did it, imagine the water savings there would be," she said.

Santa Monica officials estimate that rain harvesting, low-flow toilets and other conservation measures save the city about \$326,000 per year. If the city becomes self-sufficient by 2020 as planned mainly by tapping groundwater, it is expected to save \$3 million per year.

"Every drop counts," water resources manager Gil Borboa said.

California's drought has caught the attention of foreign leaders. During a recent three-day swing through California, Israeli Prime Minister Benjamin Netanyahu told Gov. Jerry Brown that the semi-arid country has no water troubles because it emphasizes desalination, wastewater recycling, irrigation that uses less water than traditional sprinklers and other measures.

Kevin Wattier, Long Beach Water Department general manager, said incentives are important, but there's no substitute for educating people to stop watering sidewalks.

kids can have an easier time hiding the habit from their parents and teachers.

"We have just worked so hard to stop smoking in public places," Holbrook said. "This just encourages a new avenue to begin smoking, which is really not in the public's best interest.

The battery-powered vaporizers, which deliver a form of nicotine and can mimic the feel of traditional cigarettes, are being marketed as a healthier, less difficult way to kick the tobacco habit. It's one of the reasons why sales of e-cigs have soared from about \$500 million in 2012 to an estimated \$1.5 billion in 2013. That's a fraction of the tobacco cigarette market — roughly \$100 billion per year — but it reflects rapid growth in contrast to the steady decline in traditional cigarette sales

Cities have stepped up to regulate the use of e-cigs instead of waiting for the federal government to determine if they are a health hazard or harmless. By not allowing vaping inside bars or nightclubs, e-cig users will suffer the same fate of traditional smokers. They'll have to leave their friends and the excitement. For some, that was the reason to get a vaporizer in the first place — to not be pushed out.

A tenants' rights group in Santa Monica is advocating for bans on their use. Santa Monicans for Non-Smoking Renters Rights, which helped pressure the City Council into enacting some of the most comprehensive smoking bans in the country, called on the Planning Commission late last month to recommend the council consider e-cigs to be as dangerous and damaging as tobacco cigarettes.

Willow Evans, a member of that group, went so far as to ask the commission to recommend creating a special category for e-cig shops, granting them permission to open only if they were located a certain distance from schools.

"The thing is, just because the smell isn't as noxious as cigarettes, doesn't mean it isn't toxic to breathe first hand or second hand," Evans said. "The information that e-cigs are safe is coming from the cigarette companies that bought the e-cig companies. And, those corporations have already been charged with racketeering for withholding evidence that cigarettes are not safe. So whom do we believe about the safety of e-cigarettes, the public health professionals, or the cigarette companies?"

Studies are being released regularly but

there's no consensus. Since the technology is new, long-term effects cannot be known.

The Food and Drug Administration intends to propose a regulation that would extend the agency's "tobacco product" authorities, which currently only apply to cigarettes, cigarette tobacco, roll-your-own tobacco, and smokeless tobacco, to other categories of tobacco products that meet the statutory definition of "tobacco product."

The agency admits further research is needed to assess the potential public health benefits and risks of electronic cigarettes.

Opponents point to some studies showing that those near people vaping can be exposed to nicotine and nanoparticles released in the vapor. One study showed the vapor contained metals like tin, copper and some nickel.

Supporters tout other studies, including one released recently which said they pose no danger to users or bystanders.

"What we are seeing here is not a genuine concern for public health, but a fear that e-cigarettes are going to normalize smoking," said Julie Woesser, legislative director for Consumer Advocates for Smoke-Free Alternatives, an all-volunteer organization advocating for more diversity in the marketplace when it comes to e-cigs, which they say are 99 percent less hazardous than tobacco cigarettes.

"Anything we do to discourage the adult use of e-cigarettes is working against public health," Woesser said, because e-cigs have been shown to help kick the addiction to tobacco, which has been blamed for a host of health problems, including cancer, heart disease and emphysema.

Santa Monica Councilman Kevin McKeown said he supports Holbrook's request for more information.

"From my own contact with people vaping, there doesn't seem to be the same eye and throat irritation, and since there's no combustion there is less likelihood of tar and particulates being imposed on a bystander," he said. "However, vapor may carry nicotine, which remains a concern.

"Our local laws on smoking have been driven by health issues," he added. "I think we need to understand whether second-hand vapor carries the same carcinogens and has the same negative health impacts as second-hand smoke, and then weigh our legislative options accordingly."

Councilwoman Gleam Davis is leaning toward adding e-cigs to the city's current tobacco ban, but also would like more research.

"There's plentiful research out there that shows that they're not getting to bed," he said. "But it turns out it's not social media or video games."

It likely has something to do with two of the hormones, melatonin and cortisol, that regulate our circadian rhythms, he said. As teenagers, new hormones are being released and they're all out of whack.

Fuller brought the idea of opening at 9:15 a.m. to his colleagues last year. Given that Olympic is about a 20th of the size of Santa Monica High School, making the change was easier.

Still, Fuller says that later openings would benefit all the high schools in the district. He will present his findings to the Board of Education at a meeting later this year.

"I think it could definitely work across the board," he said.

About 30 percent of the students that Fuller polled did not like the change. Olympic added an extra optional class at the

beginning of the day, from 8:45 to 9:15 a.m. All of the teachers have shifted their prep periods to the beginning of the day. They are working the same number of hours and complying with the union's standards, he said. The teachers like the change, he said.

Fuller hopes that down the road they can work out a system that would allow the early risers to take the morning class and leave early.

He continues to monitor data from the changes and says that anecdotally he's still seeing attendance improvements. He's also monitoring academic improvements and will have more information on that later this year.

"I think some people are resistant to the idea because they think it's coddling the students," he said. "They like to talk about walking to school in the snow uphill both ways and it's all a fantasy. These students today have an unbelievable amount of pressure on them and if we can make changes that will help make them more successful then we should."

Djokovic beats Federer to win Indian Wells title

INDIAN WELLS, Calif. Novak Djokovic beat Roger Federer 3-6, 6-3, 7-6 (3) to win the BNP Paribas Open for the third time on Sunday.

Federer rallied from a break down and a 5-3 deficit in the third set to force the tiebreaker, but he made a slew of mistakes to lose the 33rd meeting between the rivals.

Federer still leads the series 17-16, having beaten Djokovic in three sets in the semifinals at Dubai two weeks ago. Djokovic will remain No. 2 in the world, while Federer will rise three spots to No. 5 on Monday in the ATP Tour rankings.

Flavia Pennetta routed injured Agnieszka Radwanska 6-2, 6-1 to win the women's title, the biggest of her career.

Federer was trying to win a record fifth title in the desert, and at 32, he would have been the oldest Masters 1000 winner since 34-year-old Andre Agassi won at Cincinnati in 2004.

But Djokovic wouldn't allow it.

After Federer breezed to the first set in 31 minutes, Djokovic settled down and locked into the punishing rallies that marked most of the match. He earned the lone break of the second set to go up 5-3 after Federer pulled a forehand wide.

Djokovic got the early break in the third, again on one of Federer's forehand errors, to lead 2-1. His 112-mph ace gave him a 4-2 lead, and he extended it to 5-3 with a backhand winner down the line.

Federer served a love-game to trail 5-4 and then broke Djokovic on a forehand error to tie the set, 5-5. Federer held at love again and Djokovic gave up just one point on his serve for a 6-all tie.

The Serb raced to a 5-1 lead in the tiebreaker, helped by four errors from Federer. Another of Federer's forehand errors gave Djokovic a 6-2 lead before the Swiss star's ace ensured Djokovic would have to win the match on his serve. He did, when Federer's backhand landed in the net.

Djokovic's victory evened their rivalry on hard courts at 13 wins apiece.

A year ago, Pennetta was close to retiring from tennis.

Her ranking plunged to 166th in the world in June, and she had struggled to rebuild her career after having right wrist surgery the previous August.

Now she's glad she stuck around.

"After so many years, so much work and

everything, this is the moment I always waited for," she said. "And it's coming when you don't expect. It was something I was waiting since long time, and finally I have a good trophy in my hands."

Actually, the crystal trophy was so heavy, she didn't hoist it for photographers.

The 32-year-old Italian became the thirdoldest winner of the desert tournament after Martina Navratilova, who won at age 33 and again at 34 in 1990-91. It was Pennetta's first title since winning at Marbella in 2010.

"We are old, but we still good athletes," Pennetta said. "We are strong. We have so many years on the tour, and we know how to handle the emotion and everything."

As the 20th seed, Pennetta became the lowest seed to win the title. She came in ranked 21st and is projected to rise to No. 12 in the world Monday in the WTA Tour rankings. She beat top-seeded Li Na in the semifinals on her way to winning the title worth \$1 million.

Radwanska, seeded second, was bothered with a left knee injury during the final. She twice called for the trainer in the second set and had her knee heavily taped. She was in tears apologizing to the sympathetic crowd afterward, saying she was unable to run.

"I had the tape stronger and stronger every changeover," Radwanska said. "I thought that going to help, but not really. Didn't work."

Pennetta threatened from the first game of the match, when she held two break points and had one more in the third game. She finally converted in the fifth game on Radwanska's errant backhand, then broke again in the seventh game on the Pole's forehand error. Pennetta won the final five games to wrap up the first set, 6-2.

Radwanska held for a 1-0 lead in the second before she got the trainer on court and Pennetta called for her coach. Pennetta staved off a break point to hold at 1-1, the last challenge Radwanska offered before it became evident she wasn't herself.

Radwanska said she hurt her knee a few days ago in practice.

"I just didn't expect it was going to be much worse today," she said. "But when the pain is so big that nothing is working — no painkillers, no tape — that means it is bad."

Pennetta's lob over Radwanska, who didn't even try to go after it, helped her earn the break and a 2-1 lead. The Italian swept the last six games, with Radwanska ending the match on three consecutive errors.

She earned \$500,000.





Users urinate into a ceramic basin and flush the waste with run-off hand-washing water into a bed of bamboo plants. Bucknum claims minimal maintenance and an odor-free experience, but on the other hand, only a user's midsection area is blocked from public view -- a concession necessitated by San Francisco's sour experience with lockable public toilets, which shielded sex acts and crime. (A less-elaborate structure -- the open-air, similarly privacy-challenging "pPod" -- is currently being readied for deployment in the city's Dolores Park.)

■ Branko Bogdanov, 58, his wife, Lela, 52, and daughter Julia, 34, were arrested in March and charged in a 10-year shoplifting enterprise run out of their upscale Northbrook, III., home, which they allegedly used as a base while prowling stores in states as far away as Florida, stealing high-end toys and jewelry, which they resold on eBay and to their fences. Police estimate the Bogdanovs swiped as much as \$7 million worth on their forays -many items being stashed in Lela's customized flowing skirts with hidden pockets.
